Kris Bulcroft called the meeting to order at 4:00 p.m. and welcomed Grace Makarewicz, new University Librarian and Dolly Reno, new CSU representative.

1. APPROVAL OF AGENDA

3. CHAIR AND VICE-CHAIR'S REPORTS

Chair's Report

Senate was informed of the Northwest Commission of Colleges and Universities site visit October 24 - 26th. As this is the initial visit after being accredited new status, Kris requested that the campus community make every effort to be available during the site team visit.

Kris reported that the Board retreat had been productive and issues discussed included the role of the Board, fund raising and challenges facing the secondary education environment.

Vice-Chair's Report

Marion thanked everyone for attending, and all those involved with, the recent Budget Committee forum.

4. APPROVALS IN PRINCIPLE

Introduction to Cultural Tourism Presented by: Jean Bennett

Introduction to Cultural Tourism is a new non-credit program which will be offered at the Sunshine Coast Campus. The program will introduce students to the tourism industry with an emphasis placed on sustainable cultural tourism and the importance of in-depth knowledge of Aboriginal history and traditions of the Sechelt Indian Band Nation in the context of the tourism product delivery.

5. SENATE CURRICULUM COMMITTEE

(a) Resolutions

Jackie presented the resolutions brought forward from the January 20th Senate Curriculum Committee meeting.

6. DEVELOPMENT AND ALUMNI RELATIONS

Senate was asked for volunteers to sit on the selection committee for the Alumni Awards of Excellence. Volunteers were asked to submit their name to Janis Connolly.

7. SENATE BUDGET ADVISORY COMMITTEE

Presented by: Tammy Towill

Tammy thanked everyone involved with the recent Budget Committee forum and feedback received from the forum was now posted on Frontlines

The Committee met on January 31st to review the comments and suggestions received from the forum and to discuss steps on going forward.

Based on discussions to date, the Committee was recommending that budget issues be considered from two general perspectives: possible short-term solutions that could be applied immediately to the budget deficit, and long term initiatives which would require a review at how the University is funded and resources allocated.

Four key areas were also being considered with regard to budget issues:

- 1. Exploring seat maximums, in addition to the historically reviewed seat utilization data, and conducting a University wide audit of seat utilization and maximums.
- 2. Review of current certificate and diploma programs to determine laddering rates into other Capilano University programs.
- 3. Review and possible suspension of print advertising on campus.
- 4. Review of programs which are currently highly subsidized, have low enrolment and/or for any reason may be deemed appropriate for redesign, especially as a new degree.

The Committee will continue to work in data collection and report back at the next Senate meeting. In maintaining an open and collaborative process, a summary of the Committee's report at Senate will be sent to the campus community.

Senators were reminded of ensuring that good communication with their areas is maintained with regard to giving budget information back to their groups for consultation and discussion. Suggestions and comments should continue to be forwarded to the Committee.

8. SENATE ACADEMIC PLANNING AND PROGRAM ASSESSMENT COMMITTEE

Presented by Jackie Snodgrass

The Committee reported that at their meeting on January 24th, a sample rubric to be used for assessing assessment plans was reviewed. A sub-committee was given the task of doing further edits and providing a preamble on how the rubric would be used. The refined rubric will be used to go through a sample assessment plan to determine whether further changes to the rubric are required. The Committee will continue its work with regard to reviewing assessment plans and assessment reports.

9. SENATE BY-LAW, POLICY AND PROCEDURE COMMITTEE Presented by: Robert Campbell

(a) Ethics Policy (EC2002-01 Research on Human Subjects)

Senate was requested to approve revisions to the EC2002-01 Research on Human Subjects policy. The proposed policy follows the standards and recommendations of the Tri-Council Policy Statement: Ethical Conduct for

Research Involving Humans, and with the guidance of Cara Zaskow, Senate reviewed the policy as presented.

Cara informed Senate that the framework of the policy was based on the 2010 Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans and research based on practices at other institutions. Cara noted two sections of the policy, Section D8 Ethical Review of Course-based Research and Section J: Governance of Research Ethics Review which specifically reflect practices at Capilano University.

During the review, it was suggested that a header indicating a required review date be included in the policy.

Robert Campbell moved and David Clarkson seconded that:

12/08 The revisions to EC2002-01 Research on Human Subjects be approved by Senate.

(b) Capilano University Senate Election Procedures: Eligibility to Nominate, Vote, Run and Hold Office (Students)

Senate was reminded that at the previous Senate meeting, the Capilano University Senate Election Procedures were passed with the exception of the section on Student Eligibility to Nominate, Vote, Run and Hold Office and that Senate had requested the section be brought back for further Committee review.

At its meeting, the Committee developed revised language and, accordingly, presented their recommendations for approval to Senate.

Robert Campbell moved and Jackie Snodgrass seconded that:

12/09 The revised language on Student Eligibility to Nominate, Vote, Run and Hold Office be added to the Capilano University Senate Election Procedures.

(c) Rescind EC2004-01 Professional Behaviour in Career Programs
Post: Some Examples of Professional Behavioural Outcomes and
Measurement Criteria

Senate was requested to rescind policy EC2004-01 Professional Behaviour in Career Programs as relevant information in the policy was incorporated into the recently approved Course Outline and Approval policy.

The policy also contained a large section of information deemed useful for faculty and it was determined by the Committee that although the section of information did not warrant status of a separate policy, it would, however, be beneficial to maintain this information as general guidelines. In this regard, it was decided that the remaining information be posted as a document on the Intranet.

Robert Campbell moved and Jean Bennett seconded that:
