As per the Strategic Plan, an ad hoc advisory committee has been created to give advice to the University community on the creation of general education. This advisory committee includes a representative of each of the five Faculties and the Library, as well as the Dean of Arts and Sciences, the Registrar, and the VP Academic-Provost.

Also as per the Strategic Plan, a similar committee looking at the Cap Year Experience is in the process of being organized.

An external consultant is on campus to do a review of the enrolment management practices. This is the SEM review stated in the Strategic Plan.

Upon further discussion, clarification was requested on whether there was an opportunity for student representation on the ad hoc committees. The VP Academic-Provost will follow up in this regard.

8.3 Academic Planning and Program Assessment Committee
