SCC was requested to approve three new 3-credit courses, LAW 303 – Criminal Law II, LAW 461 – Private International Law and LAW 468 – International Climate Change Law, as well as Cap Core designation under the heading of *Self and Society* for LAW 461 – Private International Law and LAW 468 – International Climate Change Law.

During the discussion, it was suggested that it may be beneficial to review the wording and choice of verbs used for the student learning outcomes.

Stephen Williams moved and Rachel Yu seconded:

21/78 The three new courses, LAW 303 – Criminal Law II, LAW 461 – Private International Law and LAW 468 – International Climate Change Law, as well as Cap Core designation under the heading Self and Society for LAW 461 – Private International Law and LAW 468 – International Climate Change Law, be recommended to Senate for approval.

Bachelor of Legal Studies (Paralegal) Degree Program Profile Paralegal Certificate Program Profile Legal Administrative Assistant Certificate Program Profile Presented by: Deb Jamison

SCC was requested to approve the following revisions:

- Bachelor of Legal Studies (Paralegal) Degree Program Profile:
  - O In order to ensure clarity that applicants' top five academic courses in Grade 11 and 12, including English 12 or equivalent, will be considered as part of the admission requirements, the admission requirements are being revised to include "Grade 11 or 12" academic courses.
- Paralegal Certificate Program Profile
  - The School of Legal Studies requires that Paralegal Certificate applicants be employed full-time in a legal office setting in order to be eligible to enroll and continue to be enrolled in the Certificate program. This is because the Certificate students are not required to complete a sixmonth practicum and they are expected to receive procedural training during their full-time employment. However, for unknown reasons, this language was not included in either the admission, continuation, or graduation requirements and, as such, the wording is being revised to include "full-time" employment.
- Legal Administrative Assistant Certificate Program Profile
  - As the current admission requirements for the Legal Administrative Assistance Certificate (LAA) limit the number of students who apply to the program and are not in line with other competitors, SCC was requested to approve removing the LGST English Diagnostic Test and the Keyboarding test from the LAA admission requirements.
  - The School of Legal Studies requests approval of revisions to the LAA program profile so that students who complete LGST 127 and LGST 128 in the LAA program and who are later accepted into one of the three paralegal programs be given credit for LAW 115 Legal Document Processing (3.0 credits). This will eliminate duplicative content and will make our various paralegal programs more attractive to LAA graduates.

The inconsistency in CAEL and PTE scores for the Pathways is likely due to a simple transcription error that occurred when the programs were in the development stage. As a result of this inconsistency, SCC was requested to approve the revision of the minimum English language requirements for admission to both the Business Administration Pathway and the Early Childhood Care and Education Pathway to indicate a CAEL score of 50 (from 40) and a PTE score of 50 (from 47).

However, the EAP Department 100 level lists PTE 53 as prerequisites. The inconsistency in PTE scores for the Post-Baccalaureate Diploma in Global Hospitality and Tourism Management is likely due to a simple transcription error that occurred when the program was in the development stage. As a result of this inconsistency, SCC was requested to approve the revision of the minimum English language requirements for admission to the Post-Baccalaureate Diploma in Global Hospitality and Tourism Management to indicate a PTE score of 53 (from 50) to match with the entry point of EAP 100/101 level.
