KINE 405 - Exercise Management in Symptomatic Populations *Presented by: Caroline Soo*

SCC was requested to approve the addition of HKIN 205 as a prerequisite for KINE 405 – Exercise Management in Symptomatic Populations (to HKIN 205 or KINE 306). When the degree was created, HKIN 205 was converted to KINE 306, and KINE 306 is equivalent to HKIN 205. When the course outline for KINE 405 was prepared, KINE 205 was left out and SCC was therefore requested to approve the addition of HKIN 205 as a prerequisite.

The inclusion of HKIN 205 will allow students from the former HKIN Diploma program to ladder into the Bachelors of Kinesiology Program.
