As courses are created, they will be brought through the College approval process. MOAO 100 Medical Terminology I, MOAO 101 Medical Terminology II and Related Anatomy and Physiology, MOAO 120 Medical Transcription and MOAO 130 Medical Administrative Procedures are new courses. The Committee requested that Marion Haythorne confirm the credits of MOAO 120 as either 1.5 or 3.0 and the total number of credits as being either 21.75 or 20.25.
