#### 3. EARLY CHILDHOOD CARE AND EDUCATION

Bachelor of ECCE – Admission Requirements Presented by: Violet Jessen

On a suggestion made by the Degree Quality Assessment Review Panel, the Committee was requested to approve a revision to the admission requirements of the Bachelor of Early Childhood Care and Education to include a letter of intent instead of a letter outlining career goals.

Itidal Sadek moved and Marion Haythorne seconded that:

**09/01** Removing the line "a letter outlining career goals" and replacing with "Letter of Interest/Intent" in the admission requirements of the Bachelor of Early Childhood Care and Education be recommended for approval to the Senate.

In order to reflect industry needs, Tourism and Outdoor Recreation requested revision to the Certificate in the Mountain Bike Operations Program Profile with an upgraded first aid course and the addition of a marketing course.

#### 5. SCHOOL OF MOTION PICTURE ARTS

Fundamental Lighting for Digital Imaging and Film Program ELDF 100 – Fundamental Lighting for Digital Imaging and Film Fundamental Grip Work for Digital Imaging and Film Program GRDF 100 – Fundamental Grip Work for Digital Imaging and Film Presented by: Jim Wallace

Fundamental Lighting for Digital Imaging and Film Program and Fundamental Grip Work for Digital Imaging and Film are two new four-week programs designed to meet the particular and changing needs of the motion picture industry. Each program consists of one 3.0 credit course. The two programs will run concurrently as students in both programs will be working on the same film set up. The key elements being addressed in the program are new technologies and technical challenges in the lighting and motion picture production. Students completing these programs will be well qualified as entry level technicians in the Vancouver film service industry and in independent productions. It is anticipated that there will be a strong demand for the two new programs due to the upswing in the local film industry.

Jennifer Moore moved and Peter Holden seconded that:
