Early Childhood Care and Education Diploma Program Profile
Bachelor of Early Childhood Care and Education Program Profile

As a response to current trends in ECCE the diploma program was revised to give students the option of specializing in either the infant Toddler stream or the Special Needs stream in ECCE. The change to the diploma option will change the sequence of courses in the Degree program and these students will have the choice of first completing all of the Infant Toddler courses or all of the Special Needs courses and have to complete both specialties.

During the discussion, it was noted that the diploma is not meeting the requirements for English. This could be achieved by moving PSYC 100 in the fourth term of the diploma to the sixth term of the degree and moving English or Communications course in the sixth term of the degree to the fourth term of the diploma. It was agreed to do so.

The admission requirements for the Business Administration Advanced Certificate, Business Administration Diploma and the Bachelor of Business Administration (BBA) Degree are being revised to reflect changes to the high school math curriculum and to recognize BTEC 115 as an equivalent math pre-requisite in the degree.

During the review of the admission requirements, it was suggested that the new English language requirements which include the addition of ESLF 080 with a minimum mark of B+ (76%) and adding the Pearson Test of English (PTE Academic) with a score of 56 also be included in the admission requirements.

The two program profiles are being revised with the addition of IBUS 255 Cross-Cultural Business. This course will provide students with a required background to effectively communicate and negotiate with people of different cultures and allow students to graduate with a global perspective.

A note indicating that students wanting to obtain multiple advanced diplomas should be aware that each advanced diploma requires 15 unique credits as well as courses from a minimum of two subject areas in the upper level business electives is being added to the program profiles.

In order to ensure breadth of academic electives, a note restricting the number of ECON credits within the BBA to 6 excluding ECON 111 and ECON 112 is also being added to the program profiles.

As a result of changes recommended by the BC Provincial HCA Program Approval Committee to set specific contact hours as prescribed standards, the Capilano HCA program no longer meets the standards for contact hours as set out by the new policy.
