# 3. HEALTH CARE ASSISTANT

HCA 112 – Practice Experience in Home Support and/or Assisted Living Presented by: Rosemary Leffelaar

As the current prerequisites for HCA 112 were added without concurrency and results in students not being able to register for the course, SCC was requested to approve adding concurrency to all course prerequisites on HCA 112.

#### 4. ENGLISH

Change of Waiver for Writing the EDT Presented by: Reg Johanson

The English Department requested approval to change the waiver for the writing of the EDT for high school students from 86% in English 12, based on final grades, to 75% in any English 12 course, based on interim grades. The revisions will allow students to register before their final grades are released and will decrease the number of students needing to write the test. The Department requested that the change take effect in the 2012-2013 academic year.

11/62 The revision to the waiver for the writing of the EDT for high school students from 86% in English 12, based on final grades, to 75% in any English 12 course, based on interim grades and the change taking effect in the 2012-2013 academic year be recommended for approval to the Senate.

11/63 The elective structure of the Bachelor of Communications Studies revision to 42 elective credits, no more than 18 of which are to come from any single faculty and at least 18 of which must be upper level credits, plus six credits of a foreign language be recommended for approval to the Senate.
