The revisions to the admission requirements will better align the "Specific Admission Requirements" between the diploma and degree programs in an attempt to raise the academic standard of students coming into both programs.

As a result of the renumbering of BBIO 036, the pre-requisites for the follow-up courses will be affected. SCC was requested to approve revisions to the prerequisites of BBIO 043 ABE Advanced Biology I and BBIO 053 ABE Provincial Biology I. The pre-requisites are being revised to indicate the renumbered course BBIO 036, and that the ABE Department will be offering a Science Placement Test to students who have experience that may be equivalent to the BBIO 036 course.

BBIO 044 and BBIO 054 are follow-up courses to BBIO 043 and BBIO 053 and can only be taken in sequence as follow up to the other courses (BBIO 044 follows BBIO 043, and BBIO 054 follows BBIO 053). As such, the prerequisites are required to be reflected in the course outline and University calendar.

3. For upper level electives, 6.00 credits of upper level science courses will be recommended and that no more than 12.00 credits outside of the Faculty of Arts and Sciences.

5. All newly admitted Liberal Studies students will be required to take LSBA 330 Methods of Inquiry and that students who choose to complete the LSBA Extended Graduating Project will only need to complete 21.00 upper level electives or 9.00 lower or upper level electives.
