It was noted that the Continuing Education title should now read Continuing Studies, reflecting the new name: "Continuing Studies and Executive Education."

A series of Continuing Studies courses were presented for approval.

On review of AADG 901 Painting with Todd Clark, it was suggested to remove the name of the specific artist being studied so that in future, the course remains open for study of other artists. In this regard, it was suggested that the title of the course be changed to "Painting with the Artist", or some other variation which excludes the name of a specific artist.

Although no vote was taken, members generally agreed that for future practice, course titles not include specific names.

On review of GNLG 919 Creativity & Achievement: Living a Creative Life, concern was expressed that the title may not accurately reflect the course

content. As a consensus was not reached in determining an alternative title, this course was not approved and will be brought back to the December meeting.
