The items were presented for approval to SCC in the following order.

Revisions to the admission requirements of Business Administration Diploma, Business Administration Advanced Certificate and Bachelor of Business Administration. The admission requirements are being revised to include more options for math to reflect changes in the B.C. high school math curriculum and to include the corresponding Capilano University courses, and to change the minimum grade for Applications of Math 12 from "B" to "pass" to be consistent with the Math 11 requirements.

Susan Bell moved and Jerome Genz seconded that:

**13/86** The revisions to the admission requirements of Business Administration Diploma, Business Administration Advanced Certificate, and Bachelor of Business Administration be recommended for approval to the Senate.

The pre-requisites of BADM 102 are being revised to align with the new math admission requirements for the BBA Degree, BADM Diploma and BADM Advanced Certificate. The pre-requisite is necessary because BADM Certificate students can register in BADM 102 and the admission requirements for the BADM Certificate program do not include mathematics.

Robert sought clarification about the note on page two of the BADM 102 outline: "The final examination MUST BE PASSED in order to receive credit for the assignment grades."

The pre-requisites of BFIN 331 are being revised to ensure that correct wording is used to describe the required 60 credits, to ensure that students are at an intermediate level and to specifically require English 100.

Natahsha Prakash moved and Anna Lee Boulton seconded that:

**13/87** The pre-requisite revisions to BADM 102 Quantitative Methods and BFIN 331 Assurance & Auditing I be recommended for approval to the Senate.

BFIN 412 Assurance & Auditing II is a new course designed to comply with the new CPA pre-requisites.

**13/88** The new course, BFIN 412 Assurance & Auditing II, be recommended for approval to the Senate.
