The admission requirements are being revised by removing the two grade 12 academic courses (and offering MUS 109 as a remedial course), as well as changing the theory entrance exam to a theory placement exam. The program profile is being revised by changing the admission notes to reflect the admission requirements revisions.

The Diploma in Human Kinetics requires revisions to its admission requirements (Math requirements) and the removal of four courses and addition of four courses (approved by SCC in May 2019).

WGST 347 – Women and Prisons: Gender Confined *Presented by: Kirsten McIlveen*

WGST 347 – Women and Prisons: Gender Confined is a new third year elective course and is intended for all students. It will enhance WGST's upper level course offerings and will appeal to any student interested not only in women's and gender studies, but also in topics such as crime and punishment, surveillance and security through a gendered lens. SCC was also requested to approve this course for Cap Core designation under the heading *Self and* Society.

On review of the course, it was suggested that, under Evaluation Profile in the course outline, an asterisk be added to "Preparedness, Participation and Engagement" to indication an explanation for that evaluation item below.

North American Business Management Post Baccalaureate Diploma – Admission Requirement North American Business Management Applied Post Baccalaureate Diploma – Admission Requirement North American and International Management Graduate Diploma – Admission Requirement Presented by: Enrique Gonzalez

The admission requirements of the North American Business Management Post Baccalaureate Diploma, the North American Business Management Applied Post Baccalaureate Diploma, and the North American and International Management Graduate Diploma are being revised as follows:

- changing the cumulative GPA from a completed undergraduate degree from a recognized institution to 2.5 or higher (instead of 2.0) with preference given to students with a 3.0 or higher (instead of 2.5) in their final two years of study;
- changing the English Language Proficiency requirements to: Test of English as a Foreign Language (TOEFL): paper=560, internet=83, or English Language Assessment (ELA)=145, or International English Language Testing System (Academic IELTS)=6.5 overall, and no one score less than 6.0, or Canadian Academic English Language Assessment (CAEL)=70, or Pearson Test of English (PTE Academic)=56, or Capilano University EAP 100 and 101 with a minimum mark of B+ (77%) in each course, or from approved pathway partner [note that EAP 100 and 101 have replaced EAP 090]; and
- removing the two-page letter of intent.

 (a) NABU 334 and BUES 305 – Learning Outcome Revisions (fewer) A suggestion was presented to consider including indigenous content in these two courses.
