During the discussion, it was suggested that Math 097 with a "C" grade be added as one of the math options for admission to the program, and this was so approved.

- The last paragraph of the new progression language for the Engineering Transition Program on page 29 of the package is to read, "These requirements must <u>also</u> be met in order to be eligible for graduation. Students not eligible for graduation may continue as Science students <u>or</u> apply to another program.
- The comments section at the top of the new profile for the Engineering Transition Diploma on page 32 of the package is to read, "Comments: This diploma program must <u>normally</u> be completed within two consecutive academic years."

Julia Denholm moved and Marnie Findlater seconded:

16/82 The revisions to the Engineering Transition Diploma program profile, including the addition of the timeline limit for completion, revisions to the description of preparatory course requirements, and the addition of more courses at the second year level be recommended to Senate for approval.

Tourism Marketing and Development Post Baccalaureate Diploma

Hotel and Resort Management Post Baccalaureate Diploma

The Tourism Marketing and Development Post Baccalaureate Diploma and Hotel and Resort Management Post Baccalaureate Diploma were presented for final approval, and new courses that form part of the Diplomas and revisions to TOUR 325 were presented for approval.

The Tourism Marketing and Development Post-Baccalaureate Diploma is a new two-year, 45-credit program that is designed for students who have completed a baccalaureate degree and are seeking to specialize in tourism and hospitality with particular interest in a career in destination, community and/or independent enterprise marketing and development.

The Hotel and Resort Management Post-Baccalaureate Diploma is a new twoyear, 45-credit program that is designed for students who have completed a baccalaureate degree and are seeking to specialize in tourism and hospitality with particular interest in a career in hotel and resort management.

During the review, members noted that the wording of the learning outcomes of the proposed new courses do not use measurable verbs and that, in consultation with the area's SCC representative, they should be revised to reflect current accepted language. As well, it was suggested that "Admission to the Hotel and Resort Post-Baccalaureate Diploma or the Tourism Marketing and Development Post-Baccalaureate Diploma" be inserted as prerequisites for the courses in these programs (instead of having no pre-requisites).

Annabella Cant moved and Marnie Findlater seconded:

SCC recommends that Senate approve of the new courses, TOUR
371 – Applied Service Management in North America; TOUR 372
Tourism and Hospitality Practicum; TOUR 373 – Convention Management Service; TOUR 374 – Hospitality Operations: International Context; TOUR 470 – Applied Digital Marketing Strategies in Tourism; and TOUR 471 – Hotel and Resort, Human
