SCC was informed that the Jazz Studies Department has been waiting for approval from the Minister of Advanced Education to implement the new B. Mus in Jazz Studies. The Jazz Studies department is already running the new Jazz Studies Diploma that comprises the first two years of the new degree. However, the prerequisites in the existing B.Mus. program profiles reference courses from the old diploma. While the department awaits final approval of the new B. Mus, revisions to the prerequisites are required in order to make it possible for students to continue without obstruction through the existing B. Mus program.

Jazz Studies will continue to accept applications to the Education, General and Arranging//Composition streams of the existing degree. Program profiles are being updated to facilitate this process, to reflect changes in course offerings and to bring the number of credits per semester into compliance with Financial Aid rules. The program profile changes will also make it much easier for students to plan and track their progress through the degree and to help ensure that students will have the correct prerequisites at the right times.
