### **COURSE FORMAT**

4 instructional hours per week for a 15 week semester, which includes two weeks for final exams.

#### **COURSE PREREQUISITES**

ACTR 100 or THTR 130; and THTR 160

#### **CALENDAR DESCRIPTION**

This is a practical course focused on continuing the development of students' skills in the art of acting and collaboration. Students will work with peers, who may include classmates, playwriting students and ASAS 261 students. Course projects will include scene work, dramaturgy, and a final performance project.

For Acting for Stage and Screen program students only.

### **REQUIRED TEXTS AND/OR RESOURCES**

There is no required text for this course. However, students may be required to print copies of scripts for readings and scene work. Specifics will be provided in class.

#### \*ASSIGNMENTS:

1. *Mid-Term Assessment:* Students will be evaluated on contributions to class in first section of term, primarily based on their collaboration, rehearsal, and performance of short projects.

- 3. *Final Actor's Project:* Students will workshop, rehearse, and perform in a short presentation.
- 4. Actor's Book: Students will complete an Actor's Book for the Final Project.

Fraud: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the

original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit hasalready been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, interceptingand removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
