COURSE FORMAT

Two hours of class time per week for a 15-week semester, which includes two weeks for final exams.

CALENDAR DESCRIPTION

This is a course designed to expand the movement abilities of the stage and screen actor. Students will perform ensemble choreography in a classroom setting and increase their skills in several styles of dance.

REQUIRED TEXTS AND/OR RESOURCES

Required texts and/or readings will vary by the instructor. Please refer to syllabus for further details.

COURSE STUDENT LEARNING OUTCOMES:

On successful completion of this course, students will be able to do the following:

- perform a variety of dance steps and combinations;
- communicate story through the medium of dance;
- understand basic dance technique and alignment;
- develop self-awareness sufficient to continue to build on knowledge;
- increase spatial awareness as an individual and in an ensemble.

COURSE CONTENT:

The content and week-by-week breakdown of the course will vary by term and instructor. The following is a sample:

Weeks 1-4	Dance techniques and conditioning exercises introduced.
Weeks 5-8	Begin choreography. Continue technique and conditioning— skills and execution. Written work due.
Weeks 9-12	Dance technique/choreography. Introduce audition skills. Technical skill assessment.
Exams: Weeks 13-15	Perform dance piece for end of term presentation. Reflection due.

ASSIGNMENTS:

In-Class Skills: In class skills will be assessed for memorization; the ability to apply, self-assess and sustain corrections; physical awareness; musicianship; and/or knowledge of terminology. Skill assessments will happen at various points throughout the term with an emphasis on improvement at individual skill level.

Written Work: This course will have assignments such as quizzes, research projects, and/or reflective assignments demonstrating critical thinking on dance styles, personal growth and/or historical dance content.

Ensemble Work: This course will have 1-2 ensemble compositions demonstrating the skills learned within this class. Retention of choreography, integration of dance and performance techniques and spatial formations and relationships will be assessed. Ensemble pieces may be performed at term end.

Professional Practices: This grade reflects the department's Professional Practices as outlined in the Student Handbook. Professional Practices and expectations specific to this class will be reviewed by the instructor.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
