### **COURSE FORMAT**

Two hours of class time, and four hours of additional activities which may include tutorials, small group work and field work. This course runs over two 15-week semesters (two terms), each of which includes two weeks for final exams.

### **COURSE PREREQUISITES/CO-REQUISITES**

EDUC 277, EDUC 373 and 12 credits of 300-level or higher EDUC; and both EDUC 473 and a 3-credit quantitative/analytical course as pre- or corequisites

### **CALENDAR DESCRIPTION**

In this course students carry out an extended, in-depth curriculum project investigating an idea, material, process, story, or topic with children, document the project using the processes and practices of pedagogical narration, and present the project in a public presentation. Students will be assisted in finding appropriate placements to engage in an in-depth curriculum project with children 0 to 5 years of age that reflects the pedagogical intentions in the BC Early Learning Framework.

During this course, students will design and complete an inquiry-based, co-constructed curriculum project and pedagogical inquiry with children and/or educators that explores interests, ideas, and concerns that have arisen during their course work and participation in the program. Through this project students will be able to:

1. Work consistently with reconceptualist perspectives in designing, documenting, and creating an in-depth curriculum inquiry with children and/or educators;
2. Discuss current reconceptualist research and literature by writing a selective literature review;
3. Develop an understanding of theory and demonstrate how it is directly materialized in the curriculum formation processes through pedagogical narrations as a curriculum practice;
4. Synthesize, interpret, and conceptualize children/educators' ideas and processes as made evident by the ability to carry out an extended curriculum project;
5. Articulate and share the pedagogical significance of their work as made evident by a public presentation such as the student research symposium and pedagogical dialogues with other educators.

**Students who complete this Capstone course will be able to do the following:**

1. Identify a topic of inquiry or practice
2. Gather and organize relevant research materials
3. Evaluate, synthesize, and apply research findings
4. Share findings or results in a means appropriate to a field of study

**Students who complete this Experiential course will be able to do the following:**

1. Critically reflect on their progress and development in the context of the course and assess the utility of the acquired knowledge, skills, and values in the learner's personal, academic, or professional trajectory
2. Apply the skills and knowledge of a given discipline or professional context, including working collaboratively in both leadership and team roles

A student who misses 10% of classes may not receive credit for this course. A faculty review will occur in the event the maximum percentage of absences has been exceeded. Program probation may be a result of the review.

At the instructor's discretion, any assignment not reaching these standards may be returned for revision and resubmission. Maximum grade assigned for a revised assignment is a "C".

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:
