#### **COURSE FORMAT**

Three hours of class time, plus an additional hour delivered through on-line or other activities for a fifteen-week semester, which includes two weeks for final exams.

### **COURSE PREREQUISITES**

45 credits of 100-level or higher coursework including 6 credits of 100 or 200-level ENGL

### **CALENDAR DESCRIPTION**

This course will focus on a specific topic in postcolonial, transnational, diasporic, or global Indigenous literature and poetics. Students will explore how writers around the world have recrafted their art in response to the forces that have shaped our global society. Readings may include both historical and contemporary works as well as texts in translation.

## **COURSE NOTE**

ENGL 320 is an approved Culture and Creative Expression course for Cap Core requirements. For the focus of the course each term, see the "Courses" page on the English Department website.

## **REQUIRED TEXTS AND/OR RESOURCES**

A selection of fiction, poetry, drama, and/or other primary works, along with critical and scholarly readings. The course may make use of a published anthology or coursepack. Specific texts will vary depending on the instructor and term.

### **COURSE STUDENT LEARNING OUTCOMES**

On successful completion of this course, students will be able to do the following:

1. Interpret and critically evaluate the literary and cultural production of a range of literary works from around the world and explore their significance within various global contexts with attention to placemaking, cultural memory, identity formation, Indigenization, and decolonization.

- 2. Develop knowledge of specific literary movements, trends, and genres against the backdrop of the history of colonization, imperialism, and globalization.
- 3. Connect the formal and expressive features of literary texts to different social, political, and economic movements in Indigenous, national, diasporic, and transnational contexts.
- 4. Analyse settler-colonial, racial, and heteropatriarchal power structures as both sustained and critiqued by literary studies and criticism.
- 5. Compose essays and oral responses with a degree of historical awareness, self-reflection, analytical rigour, and imagination.
- 6. Prepare for and participate in class discussion and seminar groups with contributions that add to the collective understanding of texts and issues.
- 7. Compose essays that conform to accepted practices for conducting research and presenting evidence while also striving to be insightful, original, and creative.
- 8. Recognize that learning is a communal experience that includes self-reflexivity about one's positionality, lived experiences, and communal/social responsibilities.

# Students who complete this Culture and Creative Expression course will be able to do the following:

- 1. Engage in creative processes including conception, investigation, execution, and ongoing critical analysis.
- 2. Identify, analyze, and critique the elements of a form of expression using its specific vocabulary.
- 3. Explain or demonstrate the connection between various events, ideas, traditions, and belief systems and the modes in which they are artistically or culturally expressed.
- 4. Interpret diverse forms of creative expression from different perspectives (e.g., artistic, historical, Indigenous, literary, scientific, philosophical).

Fraud: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting
  and removing such work from a photocopier or printer, or collecting the graded work of
  another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
