COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams. This course may be offered in mixed-mode format.

COURSE PREREQUISITES

45 credits of 100-level or higher coursework

CALENDAR DESCRIPTION

This course will illustrate the relationship between socio-economics and health issues within a global context. The burden of major global health diseases, particularly in the areas of nutrition, communicable, non-communicable, environmental health and humanitarian crises will be examined. Global health issues across the lifespan will also be addressed as will foundational topics such as ethics, principles and goals for global health, health determinants, measurements and trends in health, education, poverty, and the economy.

- 3. Analyze the impact of colonialism and racism on Indigenous peoples.
- 4. Synthesize a range of differing community perspectives on ethics and justice and explain how these perspectives can inform structural change.
- 5. Explain how contexts (e.g. cultural, historical, colonial, economic, technological) shape identity formation and social structures.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:
