### **COURSE FORMAT**

Two hours of seminar each week for a 15-week semester, which includes two weeks for the final exam period; the course also includes 6 hours field placement each week for 12 weeks.

## **CALENDAR DESCRIPTION**

This is the final course in the series designed to introduce and orient students to a variety of treatment settings over two years and prior to pre-professional practicum. Under a clinical supervisor, students partake in a graduated process beginning with observation and culminating in their assessment, planning, implementation, and evaluation of their music therapy programs in a practicum setting. In this course, students translate knowledge from other courses to develop skills in professional practice, teamwork, effective music therapy/clinical competence.

### **COURSE STUDENT LEARNING OUTCOMES**

## On successful completion of this course, students will be able to do the following:

1. Engage in continuous self-reflection and critical thinking that informs professional development and competence as a music therapist in a mental health practicum setting and towards career efficiency;

 Acquire fundamentals of charting client progress using formats and legal requirements taught in seminar and applied at practicum, as well as continued development of goal and objective writing;

- 3. Expand cultural sensitivity, competence, and humility with music therapy approaches for clients of diverse backgrounds;
- 4. Demonstrate an in-depth understanding of the primary mental health conditions, and effective ways that music therapy can support remediation of these conditions;
- 5. Apply ongoing assessment, planning, implementation, evaluation, adaptation and modification toward quality music therapy treatment methods;
- Advocate for music therapy through professionalism that includes reliability, knowledge of music therapy and the population, accountability, ongoing documentation, collegiality, inservice, and quality interventions; and
- 7. Apply verbal and nonverbal methods of counselling skills suitable to the client population that serve to support the client's abilities to work towards positive change, remediation of symptoms, and/or optimal health.

## **COURSE CONTENT**

- 1. To research the nature and treatment of major disorders found at the practicum setting.
- 2. To attend an assigned practicum for 12 weeks, for a minimum of 7 hours per week.
- 3. To observe, plan and participate in existing programs or to set up music therapy programs where none exist.
- 4. To find appropriate techniques and apply them in a way that is natural and satisfying to the student.
- 5. To document the work done at practicum.

**Academic dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

**Cheating**: Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

**Fraud**: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
- Assisting or attempting to assist another person to commit any breach of academic integrity.
