COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

COURSE DESCRIPTION

Through this course, students will be introduced to the most influential Western philosophers of the Modern era. The focus will be the metaphysics and epistemology of philosophers in both the Rationalist and Empiricist traditions - philosophers like Rene Descartes, Baruch Spinoza, John Locke, George Berkeley, Gottfried Leibniz, David Hume, and Immanuel Kant. Coverage may vary from instructor to instructor and may include the writing of philosophers bookending this core group.

PHIL 151 is an approved Self and Society course for Cap Core requirements.

- Identify and analyse the main concepts, arguments, and theories presented as the content of the course
- Outline and explain the main theories and issues in the Metaphysics and Epistemology of the philosophers studied
- Explain the historical connections and paths of influence between the philosophers
- Apply general principles of evaluation to the arguments given in support of the various theories
- Justify conclusions about the main philosophical issues in writing and debate/discussion

Students who complete this Self and Society course will be able to do the following:

- Identify potential root causes of local/global problems and how they affect local/global cultures, economies, politics, and policies
- Assess and evaluate individual and collective responsibilities within a diverse and interconnected global society
- Synthesize a range of differing community perspectives on ethics and justice and explain how these perspectives can inform structural change
- Explain how contexts (e.g. cultural, historical, colonial, economic, technological) shape identity formation and social structures

- Copying or attempting to copy the work of another during an assessment;

- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
- Assisting or attempting to assist another person to commit any breach of academic integrity.
